IMPORTANT DEADLINES

- BYU Final application and Scholarship deadline is **Monday**, **December 16, 2024**.
- University of Utah priority application Academic Scholarship deadline is Sunday, **December 1, 2024.**
- Utah State University Academic Scholarship application deadline is Sunday, **December 1, 2024.**
- Weber State University priority Academic Scholarship deadline is Sunday, **December 1, 2024.**
- Westminster University Early Action deadline is Sunday, December 1, 2024.
- <u>The Free Application for Federal Student Aid (FAFSA) application</u> <u>is now open!!</u>
 - Students and parents need to create FAFSA accounts prior to completing the FAFSA – it takes 1-7 days for accounts to be verified, so create an account early!

Reasons to fill out the FAFSA:

- Pell Grants (don't need to be paid back)
- Federal student loans
- Work study
- Required for several scholarships, including the Opportunity Scholarship!
- You never know if your status as a student will change from dependent to independent, or if there will be a change in income.

What's needed to create a StudentAid.Gov account?

Account usernames and passwords are required for the student and each parent.

- 1. Name: Full legal name as it appears on your Social Security card.
- 2. Date of Birth
- 3. Social Security Number: Required for those with an SSN. Not required for parents without one.
- 4. **Email**: Must be verified. Use a non-school email. Students will need access to this email throughout college.
- 5. **Mobile Phone/Authenticator App**: Optional to download but recommended for login, account recovery, and enhanced security.

Who NEEDS to create a StudentAid.Gov Account? Students seeking financial aid.

Biological or adoptive parents of dependent students

(with or without a Social Security Number). If parents are divorced or separated, only the parent who provides the majority of financial support to the student will need a StudentAid.Gov Account. If that parent is remarried, the stepparent may need one, too. Student's spouse, if applicable.

Who should NOT create a StudentAid.Gov Account?

- Parents who already have a StudentAid.Gov Account (parents cannot create a new one).
- Students without a Social Security Number.
 Cannot file the FAFSA. Please consult a school counselor or college adviser for alternative ways to pay for college, scholarship opportunities, and info on HB 144.
- × Grandparents, foster parents, legal guardians Siblings
- Aunts, uncles, cousins, etc.

How do I know if my parents need to create an account? What if my parents aren't a part of my life?

If students can answer YES to any of the following questions, they do NOT need parental accounts.

- Will you be 24 years of age or older as of Jan 2025, OR are you married but not separated or divorced?
- Do you have a child or another dependent to whom you provide the majority of financial support?
- Are you currently on active duty, OR are you a veteran of the U.S. Armed Forces?
- At any time since you turned 13, were you an orphan, in foster care, or a ward of the court?
- Are or were you ever a legally emancipated minor, as determined by a court?
- Do you have a court-ordered legal guardian who is not your biological or adoptive parent?
- Are you unaccompanied AND either homeless OR self-supporting and at risk of being homeless?
- Do you have an unusual circumstance that prevents you from contacting your parent(s)? Ask for more details.

Important Warning

 The StudentAid.Gov website times out if you're inactive for a short period. You must complete the setup in one session or start over.

Experiencing issues or already have an account and can't log in?

• If you have trouble or can't access your account, call Federal Student Aid at 1-800-433-3243.

Finished?

- Don't forget to save your backup code!
- Processing your identity may take 1-3 business days. During this time, you won't be able to transfer IRS tax information to the FAFSA form.

Keep your account information handy for the FAFSA each year. Take a picture or keep it in your wallet.

Checklist to Complete the 2025-26 FAFSA

Students will need:

Which parent will need a StudentAid.Gov account to consent and sign the FAFSA form?

Only one parent is required to sign if married/remarried and filing taxes jointly.
If married/remarried but filing taxes separately, BOTH parents must sign.
Parents who are unmarried and living together
BOTH must sign.

- In the case of divorced or separated parents, the
- ONE who provides more financial support to the student OR with higher income/assets must sign.
- - If a parent has remarried, stepparent info is also needed (start from the top).
- A widowed parent, not remarried, requires the signature of the surviving parent.

Dear Esteemed Educator,

The University of Utah Center for Cultural and Community Engagement will hold the 41st annual Martin Luther King Jr. Celebration during the week of January 19-25, 2025. This annual celebration strives to connect the community in celebration of Dr. King's legacy and apply his teaching to current issues.

As a part of the celebration, the Office of Alumni Relations (U Alumni) sponsors the Dr. Martin

Luther King Jr. Youth Leadership Award (MLK YLA). This award honors outstanding students from across Utah for their dedication to the beliefs of Dr. Martin Luther King Jr. through community service and leadership. The MLK YLA Selection Committee kindly invites you to identify and nominate students who meet this criteria and who demonstrate attitudes and actions of social consciousness. Please submit your nominations no later than Friday, December 20, 2024.

Students from grades 7-11 are encouraged to apply and be considered for the MLK Youth

Award for their respective class. Only one (1) award will be given per grade level. Graduating seniors are eligible to apply for the MLK Youth Award Scholarship which will recognize the top three (3) seniors. These students will receive a scholarship from U Alumni to the University of Utah, pending admission and enrollment status, for \$2,000 a year, which is renewable up to 4 years (\$8,000 total). Candidates will be evaluated by a committee comprised of alumni and staff, and those selected will be offered an award and the scholarship. The scholarship winners will also be invited to a celebratory event hosted by the University to be recognized for their accomplishment. Please review the specific requirements and details below.

This year's MLK celebration theme is "Just Dreams for Our Generation". To address this theme the review committee requests that nominated students submit their applications addressing the following:

Share their own dreams for the future while addressing issues that young leaders are tackling today to make the world more just.

Thinking about your community, both at home and in your school, and what challenges these communities face, please answer each question below:

Have you seen people or groups of people be excluded within your community?

Please give example(s) of how people have excluded you and/or other members of your community. How did this make you feel?

How do you think it made them feel?

Nomination Requirements:

Students and nominators must submit their respective materials no later than **Friday**, **December 20**, **2024**. The Selection Committee will not review incomplete submissions:

- A letter of recommendation to be submitted by a teacher, guidance counselor, employer, or community member (no recommendations from family or friends).
- Essay based on the theme of MLK Week to be submitted by the student. The submission should highlight the student's community service and leadership.

Students must also submit a photo headshot and a <u>media disclosure form</u> signed by a parent or guardian, Note: these items will be used for publicity purposes only and will not impact a student's application, nor will they be included for committee review during the selection process.

Scholarship Details:

The review committee may select a maximum of three high school seniors to receive a University of Utah tuition scholarship from U Alumni.

There is no minimum financial need nor academic merit requirement for the MLK Youth Leadership Award scholarship.

Students who receive the non-scholarship MLK Youth Leader Award during their 7-11th grade years may reapply, as new applicants, during their senior year of high school to compete for the scholarship award.

Total maximum scholarship amount will be \$8,000 per student. This is dispersed over 4 years at \$2,000 per year (\$1,000 for fall semester and \$1,000 for spring semester) and will be applied to **University of Utah tuition expenses only.** It cannot be awarded for housing, books, personal expenses, or for expenses associated with studies at any other college or university.

If scholarship awardees have additional scholarship or tuition waiver awards, the MLK YLA funds will be applied to the remaining unmet need amount not covered by other financial aid sources.

There is no provision to "cash out" this scholarship award. Therefore, should the recipient's tuition expenses be fully covered by other scholarship or financial aid sources, the MLK YLA funds cannot be dispersed.

At the time of award notifications, those selected will receive a scholarship acceptance

agreement form. The student recipient *must return the completed form to U Alumni* by July 1, 2025, and **enroll as a full-time student at the University of Utah** in order to receive the scholarship funds. To be eligible for renewal, student recipients must maintain a 3.3 GPA and be a registered full-time student at the University of Utah.

AFTER SCHOOL CREDIT RECOVERY: IMPORTANT INFORMATION

- CREDIT RECOVERY IS A CHANCE FOR STUDENTS TO RECOVER CREDITS THEY ARE MISSING SO THEY CAN EARN THEIR DIPLOMA AND GRADUATE WITH THEIR CLASS.

What is the Seal of Biliteracy?

Can you speak more than one language? If so, consider it a badge of honor — and consider applying to have an official Seal of Biliteracy added to your high school transcripts. The Seal of Biliteracy is a designation by the Utah State Office of Education signaling a student's demonstrated proficiency in English and a world language.

Who can apply?

Students are encouraged to apply their junior year but, all high school juniors and seniors who are pro cient in English and a world language are eligible to apply for the seal starting Monday, Nov. 25,. 2024 The application window closes on Friday Jan. 17, 2025.
